The Preliminary Competition Schedule of the XIII CHAMPIONSHIP OF THE AMERICAS is attached to this General Information. The Final Competition Schedule (including Training Schedule) will be distributed after the Official Entry Deadline (30 days before the Official Arrival day). The latest Schedule updates will be provided at the Technical Meeting.

3. Rules and Regulations

The XIII CAT CHAMPIONSHIP will be conducted according to the actual ISSF Rules and Regulations – Detailed information is available on the ISSF website www.issf-sports.org and on the CAT website <https://www.conatiro.org/>.

The Juries (Competition Jury, RTS Jury, and Equipment Control Jury) will be designated by the CAT to supervise the XIII CAT CHAMPIONSHIP. Qualified Range Officers / Referees holding applicable ISSF licenses will conduct the competitions.

Rifle / Pistol Equipment

Equipment Control will be conducted according to ISSF Rules using approved, calibrated instruments. Pre-competition testing is not mandatory, however, athletes are responsible for competing with legal Control for checking before the competition. All athletes are subject to being selected for random post-competition testing and will be disqualified if their equipment or clothing is not legal according to ISSF Rules.

Rifle Clothing

All rifle athletes must have ISSF seals with serial numbers on their jackets and trousers. Any rifle jackets or trousers that do not have ISSF seals must be submitted to Equipment Control for inspection and the affixing of a seal before the athlete's first competition. Jackets and trousers that were previously inspected and have an ISSF seal continue to be valid except that athletes with more than one jacket or trousers must report to Equipment Control before their first competition to confirm which jacket and which trousers they will use. All other seal numbers for that athlete will be cancelled. Athletes that wish to replace registered jacket or trousers with a new clothing item must bring that item to Equipment Control for inspection and a new seal. Previous seals will then be cancelled. Rifle athletes can have only one active jacket and trousers at any time.

Rifle Clothing Post-Competition Testing

If one panel of a rifle jacket or trousers tests 2.9 or lower, the stiffness device must be recalibrated and the panel must be retested. If it fails again, but all other panels pass, the athlete will not be disqualified, but a written warning must be given to the athlete and the ISSF seal must be cut off. The athlete can continue using this clothing for that day in that event. If two or more panels fail, the athlete must be disqualified (DSQ).

Air or CO₂ Cylinders

It is the athlete's responsibility to ensure that any air or CO₂ cylinder is still within its validity date. This may be checked by Equipment Control."

Shotgun Equipment

All skeet athletes must have ISSF seals with serial on their marker tapes. Any shooting vests that do not have ISSF seals on the marker tapes must be submitted to Equipment Control for inspection and the affixing of a seal before the competition.

Equipment Control will be conducted according to ISSF Rules using approved, calibrated instruments. Pre-competition testing is not mandatory; however, athletes are responsible for competing with legal equipment and clothing. All athletes are urged to submit any doubtful equipment and clothing to Equipment Control or the Shotgun Jury for checking before the competition. All athletes are subject to being selected for random testing during the competition. Athletes found to be in violation of the rules for guns or skeet marker tapes will be disqualified.

Cartridge Controls

During Qualification, athletes whose cartridges are to be tested are selected by a computer draw. Between 10% and 18% of the athletes participating in an event will be selected for cartridge **testing**. Two (2) plus four (4) cartridges will be selected from each athlete and placed in separate labeled envelopes. The two (2) cartridges must be tested, first. If both cartridges weigh 24.50 g and below, no further action will be taken. If one (1) or both cartridges weigh more than 24.50, then the four (4) cartridges in the second envelope must be tested. If the average of the six (6) cartridges weigh more than 24.50 g, then the athlete must be disqualified (DSQ).

During Final, all six (6) finalists must be tested using the same procedure. The Finalists or their Coaches/Officials must bring, as early as possible, but not later than 30 minutes before the scheduled start of the Final (Reporting Time), all the cartridges that will be used during the Finals and place them in separate Cartridge Control Boxes on the Finals field of play. The Finalists must report at least 15 minutes before the start of the Final. The Equipment Control Jury will take the necessary samples from the boxes. The boxes must be left under the supervision of a Shotgun Jury Member. Once ammunition is placed in the box, only the Equipment Control Jury or the Finalist can remove ammunition from the box. If additional cartridges are brought to a Finalist during Finals, samples from those cartridges must

also be selected for testing. All cartridge controls must be completed before the start of the Presentation of the Finalists. Any disqualified (DSQ) athlete will not be allowed to participate in the Finals.

If an athlete, uses ammunition that is not in accordance with Rule 9.4.3.1 a), then the athlete must be disqualified (DSQ).

4. Participation

Individual Events

CAT Member Federations can enter a maximum of five (5) athletes in individual events but only three (3) of them can be registered to compete in the Final for the medals. The other two (2) can only compete for the ranking points.

The maximum individual number of starts for Country and event are:

Mixed Team Events

Mixed team events will be included in the Competition Schedule. These events are: 10m Air Pistol Mixed Team, 10m Air Rifle Mixed Team and Skeet Mixed Team. ISSF Member Federations may enter a maximum of two (2) teams per mixed team event, consisting of one (1) man and one (1) woman.

In addition to the events established in the ISSF regulations, in this championship the CAT will organize the **25m. Mixed Team** and the rule will be published by the CAT soon, but in summary, it will be as follows:

11. Final (Medal Matches)

The Final consists of a Bronze Medal Match followed by a Gold/Silver Medal Match. The procedure for conducting both Matches will be the same, with appropriate Command used by the CRO in each case.

All twelve (12) athletes who qualify for the Final must report to the Finals Range Preparation Area, with all necessary equipment, at least 30 minutes before the scheduled Start Time. A two-point (2) penalty will be deducted from the score of the first competition series if one or two Team members do not report on time. Each Team may be accompanied by one Coach.

ISSF ID Number

All athletes must sign an "Athlete's Declaration" and have an official ISSF ID number issued before participation in the XIII CAT CHAMPIONSHIP.

Athletes without ISSF ID number will not be allowed to participate. ISSF ID numbers can be obtained from the ISSF Headquarters by using the official application form.

Quotas will be granted for the Santiago 2023 Pan American Games (CHI)

5. Entry Process

Preliminary and Final Entries for Athletes and Officials must be submitted to FDNTP Headquarters. Registration forms are provided, but urges the member federations CAT send your forms to the FDNTP

CAT Member Federations entering the XIII CAT Championships must submit the Preliminary Entries not later than **04 AUG 2022**.

Final Entries

CAT Member Federations must forward their Final Entries directly to the FDNTP HQ. The Final Entry Deadline (30 days before the Official Arrival Day) is **04 OCT 2022**.

Late Entries

If maximum number of athlete entries have not been reached, late Entries will only be accepted until the Final Entry Deadline (3 days before the Official Arrival day) which is **30 OCT 2022**.

Important note: Until the 3 days Late Entry Deadline, the following changes in the Final Entries are possible without restriction and additional fee:

- a) Change of names / athletes within an event
- b) Change of Status (Championship athlete ↔ “out-of-competition” athlete) within an event.

Any additional entries received after the Final Entry Deadline, from **28 OCT 2022** onwards, may not participate.

Entry Changes after the Final Entry Deadline

From **28 OCT 2022** onwards, only the following changes in the Final Entries are permitted:

- a) Replacement of a registered athlete by another already registered athlete in another event can be made only before 12:00h on the day before the Pre-Event Training for that event.
- b) Change of Status in an event: an “out-of-competition” athlete can replace a withdrawn “Championship” athlete. The withdrawn “Championship” athlete may not shoot “out-of-competition”. The exchange of athletes within an event is not permitted.

Entry Confirmation upon arrival

All Team Leaders of CAT Member Federation Delegations must report to the OC Entries Official and confirm their Final Entries. The confirmation must be completed before 12:00h on the day before the Pre-Event Training.

Cancellation

Any CAT Member Federation reduces the number of entered athletes and / or officials after the Official Entry Deadline (**04 OCT 2022**) is obligated to pay all applicable fees including entry fees and hotel room cancellation costs according to the number of athletes and entries on the Final Entry Forms originally received. If the applicable fees and costs are not paid, no member of that federation may participate.

The entry fees include all charges for registration and doping control.

Medical Services

During the competition, the Organizers will provide first aid and paramedical cover. A medical doctor will be in attendance during competition hours.

Accreditation Process

All persons involved in the XIII CAT CHAMPIONSHIP (Athletes, Team Officials, ISSF Officials, OC Officials, Media Persons) must have accreditations that clearly identify the accreditation holder (with photograph, family name and first name, nation and function) in order to use the local transportation and to enter controlled areas on the shooting range.

The accreditations (all federations must send a photograph of the athletes together with the registration forms) will be prepared by the Headquarters. All other accreditations will be prepared by the Accreditation Office of the 1st Pan American and South American Shooting Championships. Accreditations and BIB Numbers will be distributed by the Organizing Committee after payment of the entry fees.

The firing direction of the Skeet & Trap, 25m and 50m range is south east.

Shotgun

The shooting range has 4 combined ranges for Trap/Skeet.

The shooting range is equipped with 15+2 machines and 4 acoustic release system.

The Skeet ranges operate with acoustic and manual release system.

All ranges are equipped with electronic scoreboards.

The firing direction of the shooting range is south east.

The targets used for the XIII CAT Championship are eco-friendly from EUROTARGET, standard orange for the Qualification and flash orange for the Finals.

Tents for federation

There will be tents (3x3m) available at the shooting range for the federations to rent. The amount for the time of the competition is US\$600. 7. Immigration and Customs Requirements

All nations that need an official invitation from the Peruvian National Shooting Federation, must request it before **04 SET 2022** (Annex 7). Please send an email to the organizing committee, requesting it.

Unless the Organizing Committee receives a special request, the invitation will be sent by email. If an express service is requested, the cost of this service will be charged to the federation and must be paid to the Organizing Committee upon arrival.

The Peruvian National Shooting Sports Federation has no influence over the embassies.

The Peruvian National Shooting Federation can provide an invitation for the XIII CAT CHAMPIONSHIP Lima 2022 period ONLY.

Note: All fields are mandatory

Gun License

All nations must be in possession of the approved arms import form (Annex 8), certified by the Peruvian authorities. Be sure to bring a copy of your certified weapon form with you. In addition, it is recommended that all delegations carry a list of all firearms and ammunition, which will be presented to customs agents, upon request, along with the invitation.

Please fill in the forms completely and do not change the form or use your own form. Incomplete forms cannot be accepted and will be sent back. The completed forms must be submitted to the Organizing Committee by email until **04 OCT 2022** latest.

All weapons, including air guns, must be declared, as well as their ammunition.

The requirements for the temporary entry of weapons:

- 1.- Fill out the Sucamec - Affidavit form for each athlete (per weapon) if they enter with 5 weapons, there must be 5 formats. LEGIBLE LETTER
